Mr. Roselli reviewed the following Workers' Compensation Payment Authorization Requests for January, 2018:

001155730 01 – Claimant was stepping out of truck when his right foot slipped on ice and he twisted his right knee. Total Incurred Value: \$61,577.37.

2017083363 01 — Claimant was lifting a table with another employee, when the other person dropped their end and the claimant kept holding up her end and injured her left thigh, left arm and left shoulder. Total Incurred Value: \$71,746.00.

2018113285 01 – The claimant stood up on the bus to get out the car seat, when the bus turned right, causing claimant to lose her balance and striking her left knee on the seat and falling to the ground. Total Incurred Value: \$87,772.50.

2017085488 01 – While walking in the school hallway, immediately after taking the children out to the bus, the claimant slipped on a wet floor. Total Incurred Value: \$95,540.00.

2017087558 01 – While two female students were fighting, claimant intervened to break up the fight. One of the students punched the claimant multiple times in the face, back, neck and shoulder. Total Incurred Value: \$98,346.00.

2016073986 01 – Claimant was walking in the bathroom to wash his hands, when his leg gave out and he fell forward hitting the wall with his right shoulder. Total Incurred Value: \$143,273.00.

2018116124 01 – While walking in hallway claimant slipped on wet floor, causing injury to her neck, back, left shoulder, right wrist, and left hip. Total Incurred Value: \$358,816.00.
