2017085645 01 – Claimant was working on the floor of the handicap van, putting seats back in, when he went to get up and felt his right knee pop. Total Incurred Value: \$29,184.00.

0011180543 01 – A tree fell on the school bus, while traveling to the school. No students were on the bus. Total Incurred Value: \$44,591.00.

001182289 01 – Claimant was using wax stripper, when he slipped and fell on his right side. Total Incurred Value: \$44,700.00.

2017094555 01 – While walking off the basketball court after demonstrating a drill to the team, his right knee became sore and swollen. Total Incurred Value: \$50,000.00.

001185877 01 – While in the school van, a 10-year old special needs student repeatedly punched the claimant in the stomach. Total Incurred Value: 57,727.00.

2017087518 01 – While walking in the school parking lot on her way in to work (while it was still dark out) the claimant tripped, and fell on her right side and onto her back, hitting her head. She is unsure what caused her to trip. Total Incurred Value: \$59,635.00.

001170314 01 – The claimant was attempting to open a locker with bolt cutters. While applying force, the claimant lost her balance and fell into the locker, injuring her head and neck. Total Incurred Value: \$60,995.00.

2017084892 01 – While walking in hallway of a school, the claimant slipped on a wet floor, falling on left knee, injuring both shoulders, low back, and right wrist. Total Incurred Value: \$80,975.00.

001241411 01 – While driving insured's pickup truck, he was rear ended by another vehicle at 4-way stop on Leeville Road. Total Incurred Value: \$82,057.00.

001168498 01 – Claimant was walking towards the entrance of the school. It was raining that day and claimant's shoes were wet. The claimant slipped and fell on her left knee as she was walking into the building. Total Incurred Value: \$82,650.00.

2017097226 01 – Claimant was driving to a special services school in her personal vehicle, after a student evaluation at another school, when she was struck by another vehicle at an intersection. Total Incurred Value: \$114,144.00.

001210435 01 – While drying floors the claimant caught her right foot in a bucket and fell, injuring her upper back and knee. Total Incurred Value: \$125,200.00.

2017091575 01 – While walking in walk way area outside high school into work, claimant slipped and fell due to ice. Total Incurred Value: \$210,052.00.

001198674 01 – Claimant was working on the athletic fields using a "pro machine" to break frozen turf, when he hit a hole in the clay. Total Incurred Value: \$322,140.00.

001224174 01 – Claimant reported that he was pulling out bleachers when he felt pain in his back. Total Incurred Value: \$29,155.00.

001207144 01 – Claimant was setting up chairs in the gym, when he felt pain in his back and fell to the floor. Total Incurred Value: \$100,847.00.

001090459 01 – After plowing snow, claimant was exiting the truck on school property, when he slipped and fell on ice. Total Incurred Value: \$120,038.54.

001182926 01 – Claimant was working in the bus garage installing metallic piping overhead, when he felt pain in his right shoulder. Total Incurred Value: \$95,931.00.

001214043 01 – Claimant was walking into the school, when he tripped over the metal threshold in the doorway and fell to the floor. Total Incurred Value: \$113,854.00.

2017094325 01 –While walking down the hallway, claimant slipped on something wet, slid across the floor, and landed on her right side. Total Incurred Value: \$129,916.00.

2017084670 01 — While opening cafeteria tables to set up before the start of school, claimant injured her low back. Total Incurred Value: \$122,242.34.
