- 1. #2018128243 Claimant was in stairway when she slipped on a wet surface and attempted to prevent falling, injuring her right hand and right shoulder. Total Incurred value: \$120,540.93.
- 2. <u>#2019177105</u> While walking in hallway claimant's heel got caught on floor causing her to trip and fall, landing on right knee. Total Incurred Value: \$83,680.00.

- 3. #2017083151 While moving tables, file cabinets, desks and chairs to clean classroom, the claimant felt a strain to her neck, both shoulders, and lower back. Total Incurred Value: \$62,969.00.
- 4. #2016081606 Athletic Field and Equipment. Proposed Authority: \$55,000.00.
- 5. #2018123430 False Arrest. Proposed Authority: \$275,000.00.
- 6. <u>#2018145884</u> While walking down a flight of steps, the claimant twisted her left knee on the second to last step. Total Incurred Value: \$158,251.67.
- 7. <u>#2019162018</u> Student pulled on claimant's right arm and claimant heard a pop. Total Incurred Value: \$147,526.86.
- 8. #001224037 The claimant was getting out of her car in the parking lot and slipped on ice, banging her head on the car. Seeking authority for Section 20 settlement. Total Incurred value: \$139,336.00.
- 9. <u>#2019170316</u> The claimant was cleaning floors and scraping the walls when she strained her right shoulder. Total Incurred Value: \$110,766.24.

- 14. <u>#2018122386</u> While moving car seats from one bus to another, the claimant strained her lower back. Total Incurred Value: \$25,262.00.
- 15. #2018111284 Claim for alleged discrimination. Proposed Authority: \$175,000.00.
- 16. <u>#2017089782</u> Claim for alleged sexual harassment/discrimination. Proposed Authority: \$425,000.00.
