III. **CLOSED SESSION DISCUSSIONS:**

- 1. #001231489 Claimant is seeking compensatory and punitive damages. Incurred value: \$55,000.
- 2. #001191198 Plaintiff alleges she was given permission by her teacher to leave school in a personal car as opposed to her designated school bus. She was provided alcohol and then sexually assaulted by a male in the car. Incurred value: \$195,000.
- 3. #001205640 Claimant was crouched down speaking to a student near an open door, when a gust of wind caught the door and it slammed into the left side of her face. Incurred value: \$32,036.

- 4. #2016074068 Bus the claimant was traveling on as a swim coach was struck head on by a private passenger vehicle. The claimant was 37 weeks pregnant. There were no complications with her pregnancy. Her injuries were restricted to her head and face. Incurred value: \$55,727.18
- 5. #2016073973 Head on accident with private passenger vehicle. Incurred value: \$101,000.
- 6. #2016074070 Claimant was 1 of 22 students on a school bus when involved in a motor vehicle accident. Incurred value: \$40,000.
- 7. #0011958098 While lifting chairs the claimant felt a pop in her right elbow. Incurred value: \$36,409.38.
- 8. #001195095 Claimant leaned on the desk and the desk collapsed. Claimant landed on top of the desk injuring her back, shoulders, neck, and right knee. Incurred value: \$306,150.60.
- 9. #000851119 A hot water coil in the air handler cracked and water leaked. Incurred value: \$95,000.
- 10. <u>#000950961</u> Complaint alleging retaliation by insured for complaints against district. Incurred value: \$240,000.
- 11. #001190018 High school play attendee attempted to pass by a barricade and in doing so, tripped and fell into a wall fracturing kneecap requiring open reduction internal fixation (ORIF) with hardware as well as a fractured right humerus also requiring ORIF. Incurred value: \$200,000.
