2017099503 01 – Claimant was standing in the cafeteria and a student was running in from the bus, pushed claimant and caused her to fall to the floor and injure her knee and thigh. Proposed Authority: \$102,700.61.

2018129073 01 – While walking down stairs, claimant missed the 2nd to the last step from the bottom and fell, injuring left knee and left foot. Total Incurred Value: \$77,526.39.
