Be It Further Resolved, that the Chair and Secretary of the Gloucester, Cumberland, Salem School Districts Joint Insurance Fund are hereby authorized to execute Agreements with the individuals, partnerships and corporations hereby appointed for the performance of the professional or of extraordinary and unspecifiable services providing for compensation within the amounts budgeted for those services, as follows:

Geitz as its designated representative, is hereby appointed as Safety Coordinator for the Gloucester, Cumberland, Salem School Districts Joint Insurance Fund for a term commencing on July 1, 2015 and continuing until June 30, 2016, in the amount of \$48,925, of which \$33,615 is a guaranteed maximum amount for core services, and \$15,310 is a variable amount for training services, as set forth specifically in the Agreement.
