COVERAGE IMPROVEMENTS / ENHANCEMENTS / ADDITIONS

PROPERTY

- Blanket per occurrence loss limit increased from \$150,000,000 to \$175,000,000 for ALL members and new members effective July 1, 2016.
- Earthquake blanket per occurrence loss limit increased from \$75,000,000 to \$150,000,000.
- Annual Aggregate Flood Limit for All Covered Zones increased from \$50,000,000 to \$150,000,000.
- Unnamed locations sublimit increased from \$10,000,000 to \$25,000,000.

BUILDERS RISK

- Automatic Builder's Risk—Extension to Third Party Contractors sublimit increased from \$5,000,000 to \$25,000,000.

GENERAL LIABILITY

- Increased General Liability Bodily Injury Sub-Limit for Sexual Abuse/ Molestation to \$10,000,000 per occurrence.

DISASTER MANAGEMENT SERVICES

- Disaster Response Services provided by Disaster Management International following a tragedy involving the demise of five or more persons .
- Services include Media Management / Crisis Communications, Family Assistance for victims families, Behavioral Health services for surviving victims, families, affected staff and students.

UNMANNED AERIAL SYSTEMS (UAS) - DRONES

- Non-owned UAS liability for all members and owned UAS liability available following certification.
