Be It Further Resolved, that the compensation for the services shall be in accordance with the amounts budgeted for the specific services and subject to contracts hereby authorized and approved by the Trustees of the Gloucester, Cumberland, Salem School Districts Joint Insurance Fund, and

Be It Further Resolved, that the Chair and Secretary of the Gloucester, Cumberland, Salem School Districts Joint Insurance Fund are hereby authorized to execute Agreements with the individuals, partnerships and corporations hereby appointed for the performance of the professional or of extraordinary and unspecifiable services providing for compensation within the amounts budgeted for those services, as follows:

- Arthur J. Gallagher & Company as Administrator/Executive Director for the Gloucester, Cumberland, Salem School Districts Joint Insurance Fund for a term commencing on July 1, 2018 and continuing until June 30, 2019, in the amount of \$349,404, as set forth specifically in the Agreement.
- 2. Louis J. Greco, Esquire, an Attorney at Law of the State of New Jersey, is hereby appointed as the Attorney (Solicitor) for the Gloucester, Cumberland, Salem School Districts Joint Insurance Fund for a term commencing on July 1, 2018, and continuing until June 30, 2019, in an amount not to exceed \$57,000, as set forth specifically in the Agreement.
- 3. Verrill & Verrill, LLC, is hereby appointed as Treasurer of the Gloucester, Cumberland, Salem School Districts Joint Insurance Fund for a term commencing on July 1, 2018, and continuing until June 30, 2019, in the amount of \$10,000, as set forth specifically in the Agreement.

Geitz as its designated representative, is hereby appointed as Safety Coordinator for the Gloucester, Cumberland, Salem School Districts Joint Insurance Fund for a term commencing on July 1, 2018 and continuing until June 30, 2019, in the amount of \$61,565, of which \$43,255 is a guaranteed maximum amount for core services, and \$18,310 is a variable amount for training services, as set forth specifically in the Agreement.

Gallagher & Company is hereby appointed as Recording Secretary of the Gloucester, Cumberland Salem School Districts Joint Insurance Fund for a term commencing on July 1, 2018, and continuing until June 30, 2019, in the amount of \$250 per meeting and until a successor is appointed.
