Resolution No. 2018-01

Appointing Professional Staff

Whereas, the Burlington County Insurance Pool Joint Insurance Fund is duly constituted pursuant to *N.J.S.A. 18A:18B-1*, et seq., as a Self Insurance Fund; and

Whereas, the participating Boards of Education have made their respective designations of Trustees who will collectively serve as the governing body of the Burlington County Insurance Pool Joint Insurance Fund; and

Whereas, the Trustees of the Burlington County Insurance Pool Joint Insurance Fund find that it is necessary and appropriate to obtain certain professional and other extraordinary and unspecifiable services and, therefore, to make certain appointments and to authorize certain contracts for professional and other extraordinary and unspecifiable services so that the work of the Burlington County Insurance Pool Joint Insurance Fund may proceed, and

Now, THEREFORE, BE IT RESOLVED, by the Trustees of the Burlington County Insurance Pool Joint Insurance Fund, assembled in a public session on [May 9, 2018](#) that:

1. Arthur J. Gallagher Risk Management Services, Inc. is hereby appointed as Administrator/Executive Director for the Burlington County Insurance Pool Joint Insurance Fund with Paul J. Miola appointed as Executive Director. Bradford W. Hoffman, Scott Tennant and Craig Wilkie are appointed as Deputy Executive Directors. All appointments are for a term commencing on [July 1, 2018](#) and continuing until [June 30, 2019](#), and until a successor is appointed.
2. Louis J. Greco, Esquire, an Attorney at Law of the State of New Jersey, is hereby appointed as the Attorney (Solicitor) for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on [July 1, 2018](#), and continuing until [June 30, 2019](#), and until a successor is appointed.
3. Jodi Lennon is hereby appointed as Treasurer of the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on [July 1, 2018](#), and continuing until [June 30, 2019](#), and until a successor is appointed.
4. The Actuarial Advantage, Inc., with Dennis Henry as its designated representative, is hereby appointed as Actuary for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on [July 1, 2018](#), and continuing until [June 30, 2019](#), and until a successor is appointed.
5. Qual-Lynx with Alice Lihou, Senior Vice President and Chris Roselli, Account Manager as designated representatives, is hereby appointed as Claims Administrator for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on [July 1, 2018](#), and continuing until [June 30, 2019](#), and until a successor is appointed.
6. John W. Geitz, trading as Risk Assessment Services, is hereby appointed as Safety Coordinator for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on [July 1, 2018](#) and continuing until [June 30, 2019](#), and until a successor is appointed.
7. Risk Assessment Services, with John W. Geitz, President, and Hazard Mitigation Consultants, Inc., with David Roach, President, is/are hereby appointed as Right to Know Coordinators for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on [July 1, 2018](#) and continuing until [June 30, 2019](#), and until a/or successor(s) is/are appointed.

8. Bowman and Company LLP, with James Miles, CPA, as its designated representative, is hereby appointed as Auditor for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on July 1, 2018 and continuing until June 30, 2019, and until a successor is appointed.
9. Michael Colling is hereby appointed as Recording Secretary of the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on July 1, 2018, and continuing until June 30, 2019, and until a successor is appointed.
10. Qual-Lynx, with Karen Beatty, Client Services Manager as designated representative, is hereby appointed as the Managed Care and Network Provider for a term Commencing on July 1, 2018 and continuing until June 30, 2019.

BE IT FURTHER RESOLVED that the Trustees of the Burlington County Insurance Pool Joint Insurance Fund find and determine that the appointments herein specified require either professional services for which the individuals designated are licensed to practice a profession or for extraordinary and unspecifiable services that cannot be adequately described in specifications that would make solicitation of bids for those services meaningful or advisable, or are not subject to public bidding as falling within the category of insurance services, and

Be It Further Resolved, that the compensation for the services shall be in accordance with the amounts budgeted for the specific services and subject to contracts hereby authorized and approved by the Trustees of the Burlington County Insurance Pool Joint Insurance Fund, and

Be It Further Resolved, that the President and Secretary of the Burlington County Insurance Pool Joint Insurance Fund are hereby authorized to execute Agreements with the individuals, partnerships and corporations hereby appointed for the performance of the professional or of extraordinary and unspecifiable services providing for compensation within the amounts budgeted for those services, as follows:

1. Arthur J. Gallagher Risk Management Services, Inc. as Administrator/Executive Director for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on July 1, 2018 and continuing until June 30, 2019, in the amount of \$763,920 as set forth specifically in the Agreement.
2. Louis J. Greco, Esquire, an Attorney at Law of the State of New Jersey, is hereby appointed as the Attorney (Solicitor) for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on July 1, 2018 and continuing until June 30, 2019, in an amount not to exceed \$94,350 as set forth specifically in the Agreement.
3. Jodi Lennon. is hereby appointed as Treasurer of the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on July 1, 2018, and continuing until June 30, 2019, in the amount of \$14,500 as set forth specifically in the Agreement.
4. The Actuarial Advantage, Inc., with Dennis Henry, as its designated representative, is hereby appointed as Actuary for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on July 1, 2018, and continuing until June 30, 2019, in an amount not to exceed \$26,921 as set forth specifically in the Agreement.
5. Qual-Lynx with Alice Lihou, Senior Vice President and Chris Roselli, Account Manager as designated representatives, are hereby appointed as Claims Administrator for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on July 1, 2018, and

continuing until [June 30, 2019](#), for a minimum amount of [\\$265,634](#) and a maximum amount not to exceed [\\$327,500](#) as set forth specifically in the Agreement.

6. John W. Geitz, trading as Risk Assessment Services, is hereby appointed as Safety Coordinator for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on [July 1, 2018](#) and continuing until [June 30, 2019](#), in the amount of [\\$103,746](#) for core services, training fees per schedule and [\\$500.00](#) per new member survey, as set forth specifically in the Agreement.
7. Risk Assessment Services, with John W. Geitz, President and Hazard Mitigation Consultants, Inc., with David Roach, President, are hereby appointed as Right to Know Coordinators for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on [July 1, 2018](#) and continuing until [June 30, 2018](#), in an amount not to exceed [\\$20,250](#) as set forth specifically in the Agreement.
8. Bowman & Company, with James Miles, CPA, as its designated representative, is hereby appointed as Auditor for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on [July 1, 2018](#), and continuing until [June 30, 2019](#), in an amount not to exceed [\\$22,491](#) as set forth specifically in the Agreement.
9. Michael Colling is hereby appointed as Recording Secretary of the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on [July 1, 2018](#), and continuing until [June 30, 2019](#), in the amount of [\\$1,200](#) as set forth specifically in the Agreement.
10. Qual-Lynx, with Karen Beatty, Client Services Manager as designated representative, is hereby appointed as the Managed Care and Network Provider for a term commencing on July 1, 2018 and continuing until June 30, 2019 in the amount of \$481 per workers compensation file paid from the loss fund.

and **Be It Further Resolved**, that all of the Agreements set forth above are subject to approval by the Trustees of the Burlington County Insurance Pool Joint Insurance Fund, and
