Be It Further Resolved, that the compensation for the services shall be in accordance with the amounts budgeted for the specific services and subject to contracts hereby authorized and approved by the Trustees of the Burlington County Insurance Pool Joint Insurance Fund, and

Be It Further Resolved, that the President and Secretary of the Burlington County Insurance Pool Joint Insurance Fund are hereby authorized to execute Agreements with the individuals, partnerships and corporations hereby appointed for the performance of the professional or of extraordinary and unspecifiable services providing for compensation within the amounts budgeted for those services, as follows:

Gallagher Risk Management Services, Inc. as Administrator/Executive Director for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on July 1, 2023 and continuing until June 30, 2024, in the amount of \$989,784.00 as set forth specifically in the Agreement.
- 2. Patrick J. Madden, Esquire, an Attorney at Law of the State of New Jersey, is hereby appointed as the Attorney (Solicitor) for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on July 1, 2023 and continuing until June 30, 2024, in an amount not to exceed \$95,350.00 as set forth specifically in the Agreement.
- 3. Jodi Lennon. is hereby appointed as Treasurer of the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on July 1, 2023, and continuing until June 30, 2024, in the amount of \$14,500.00 as set forth specifically in the Agreement.

The Actuarial Advantage, Inc., with Erik Bause, as its designated representative, is hereby appointed as Actuary for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on July 1, 2023, and continuing until June 30, 2024, in an amount not to exceed \$29,722.00 as set forth specifically in the Agreement.

Qual-Lynx with Alice Lihou, President & CEO and Chris Roselli, Account Manager as designated representatives, are hereby appointed as Claims Administrator for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on July 1, 2023, and continuing until June 30, 2024, for a minimum amount of \$317,476.00 and a maximum amount not to exceed \$373,402.00 as set forth specifically in the Agreement.
- 6. John W. Geitz, trading as Risk Assessment Services, is hereby appointed as Safety Coordinator for the Burlington County Insurance Pool Joint Insurance Fund for a term commencing on July 1, 2023 and continuing until June 30, 2024, in the amount of \$110,411.00 for core services, training fees per schedule and \$500.00 per new member survey, as set forth specifically in the Agreement.
