## **APPOINTING PROFESSIONAL STAFF**

**Now**, **THEREFORE BE IT RESOLVED** by the Trustees of the Atlantic & Cape May Counties Association of School Business Officials Joint Insurance Fund, assembled in a public session on May 18, 2022 that:

**Be It Further Resolved**, that the compensation for the services shall be in accordance with the amounts budgeted for the specific services and subject to contracts hereby authorized and approved by the Trustees of the Atlantic & Cape May Counties Association of School Business Officials Joint Insurance Fund, and

**Be It Further Resolved,** that the Chairperson and Secretary of the Atlantic & Cape May Counties Association of School Business Officials Joint Insurance Fund are hereby authorized to execute Agreements with the individuals, partnerships and corporations hereby appointed for the performance of the professional or of extraordinary and unspecifiable services providing for compensation within the amounts budgeted for those services, as follows:

Gallagher Risk Management Services, Inc., as Administrator for the Atlantic & Cape May Counties Association of School Business Officials Joint Insurance Fund for a term commencing on July 1, 2023 and continuing until June 30, 2024, in an amount not to exceed \$852,924.00 as set forth specifically in the Agreement.
- 2. Patrick J. Madden, Esquire, an Attorney at Law in the State of New Jersey, is hereby appointed as the Attorney (Solicitor) for the Atlantic & Cape May Counties Association of School Business Officials Joint Insurance Fund for a term commencing on July 1, 2023 and continuing until June 30, 2024, in an amount not to exceed \$105,000.00 as set forth specifically in the Agreement.
