APPOINTING PRIMARY CARE PHYSICIANS

WHEREAS, the Atlantic & Cape May Counties Association of School Business Officials Joint Insurance Fund (the “Fund”) is duly constituted as a School District Self Insurance Fund and has been organized in accordance with the provisions of 18A:18B:1-10; and

WHEREAS, the participating School Districts have made their respective designations of Commissioners who, in turn, have elected a Board of Trustees for the Atlantic & Cape May Counties Association of School Business Officials Joint Insurance Fund who will collectively serve as the Governing Body for same; and
