Compliance Officer In Accordance With The Affirmative Action

WHEREAS, the Atlantic & Cape May Counties Association of School Business Officials Joint Insurance Fund (the "Fund") is duly constituted as a School District Self Insurance Fund and has been organized in accordance with the provisions of *N.J.S.A. 18A:18B:1-10*; and

WHEREAS, the participating Boards of Education have made their respective designations of Commissioners who have elected a Board of Trustees for the Fund who will collectively serve as the Governing Body of the Atlantic & Cape May Counties Association of School Business Officials Joint Insurance Fund; and

WHEREAS, the Atlantic & Cape May Counties Association of School Business Officials Joint Insurance Fund is a public agency with regard to the laws and regulations governing the award of contracts by public agencies; and

WHEREAS, the Atlantic & Cape May Counties Association of School Business Officials Joint Insurance Fund is required to designate a Public Agency Compliance Officer in accordance with Affirmative Action regulations issued by the New Jersey Department of the Treasury;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Atlantic & Cape May Counties Association of School Business Officials Joint Insurance Fund, assembled in public session on [May 18, 2016](#), that Bradford W. Hoffman, Deputy Executive Director shall be the Public Agency Compliance Officer for purposes of the Affirmative Action regulations issued by the New Jersey Department of the Treasury, and that communications to him may be addressed to:
