Mr. Roselli reviewed the following workers' compensation Payment Authorization Requests for May, 2018:

2018129353 01 – Claimant was walking to the bathroom near the football field when she slipped and fell. Total Incurred Value: \$149,626.88.

2018127812 01 – Claimant slipped while walking in the hallway, injuring her right shoulder. Total Incurred Value: \$149,167.63.

2017088478 01 – While walking into a classroom to assist a student, the claimant tripped over a small couch and fell. Total Incurred Value: \$121,965.00.

2018118277 01 – While walking between tables, claimant tripped over a student's leg and fell to the floor. Total Incurred Value: \$90,038.75.

001162786 01 – Claimant was doing outside duty and helping get kids on their buses when she lost her footing and fell to the ground. Total Incurred Value: \$75,561.38.

001161201 01 – The claimant was moving boxes of Xerox paper, when he felt a sharp pain in his mid-back and felt tingling in his legs. Total Incurred Value: \$51,325.00.

2018127141 01 – The claimant was squatting on the floor and when she stood up she fell backwards, hitting her head on a metal board. Total Incurred Value: \$43,781.41.
