001225094 – Claimant was working in the pool area and pulling off the pool cover when he slipped and fell. Total Incurred Value: \$622,637.78

2018116124 – While walking in hallway, claimant slipped on west floor causing injury to her neck, back, left shoulder, right wrist and left hip. Total Incurred Value: \$487,416.84

2022245647 – While opening up a classroom door, claimant allege he "tripped" on the doorstopper, which caused him to fall into the door. Total Incurred Value: \$238,666.24

2019168222 – Claimant was walking to her car when she tripped over her purse/bag and fell face down onto pavement injuring her nose, tooth, right hand/wrist, shoulder and bilateral knees, lumbar and cervical spine. Total Incurred Value: \$154,181.42

2021210142 – Claimant slipped and fell while scrubbing the floor causing injury to her right arm, right leg and low back. Total Incurred Value: \$97,146.20

2022250791 – While taking a class through the hallway, a student attempted to flee through stairwell and the claimant let go of a door to grab the student to stop them. Door swung shut on claimant's left knee. Total Incurred Value: \$93,519.00

2022251508 – While cleaning classroom, claimant fell onto her left leg. Total Incurred Value: \$90,824.26

2021215130 – Claimant was walking back to her office and slipped on water that was falling from ceiling onto the floor causing her to fall and injure her right knee. Total Incurred Value: \$74,905.75

2021220966 – While climbing a ladder, the claimant grasped it with his right hand and felt a pop in his right hand. Total Incurred Value: \$51,760.38

2019154473 – While standing on ground, lifting air conditioning coil out of truck with custodian, the claimant felt a pull in his lower back. Total Incurred Value: \$48,563.86

001202111 – Claimant was on the roof of the Performing Arts Building servicing a unit. He pulled himself up into the unit and when he stepped down, his right knee gave out. Claimant heard a pop. Total Incurred Value: \$43,726.76
