001080672 – Claimant was lifting a heavy trash can when she injured her right shoulder and neck. Total Incurred Value: \$349,273.10.

2021213975 – A door slammed closed, striking claimant on her back. Total Incurred Value: \$163,306.00.

2021212721 – Claimant was in the gymnasium lifting and pulling out bleachers that were stuck when he injured his left shoulder. Total Incurred Value: \$182,609.69.

001181087 – Claimant's sneakers stuck to the newly waxed floor causing her to all to the ground. Total Incurred Value: \$171,732.51.

2019148320 – The buffing machine claimant was using became tangled, causing the claimant to fall back onto the floor striking his head. Total Incurred Value: \$124,675.33.
