2022256077 – Claimant was adjusting the driver seat and as she pulled up the seat, she felt a short shooting pain in her back & leg. Total Incurred Value: \$183,398.00

2022255505 – While lifting paper cases and distributing to classrooms, the claimant felt pain in his lower back. Total Incurred Value: \$175,118.14

2022257381 – While showing a student a wrestling move, the claimant pulled his groin/left side. Total Incurred Value: \$168,211.65

2022246105 – After hanging up the phone, claimant turned around and tripped over the furniture-roller causing her to fall. Total Incurred Value: \$164,369.09

2020205718 – While standing on scaffolding (not properly secured) painting walls, the scaffolding collapsed causing the claimant to fall and injure his lower back. Total Incurred Value: \$121,427.89

2022249097 – While moving a desk the claimant injured his right thumb. Total Incurred Value: \$110,215.59

001228488 – Claimant rolled and twisted right ankle while walking down stairwell in school. Total Incurred Value: \$102,180.00

2021237734 – Claimant was driving from the high school to the middle school when his vehicle was involved in motor vehicle accident. Claimant's airbags deployed in his vehicle. Total Incurred Value: \$99,066.00

2021210142 – Claimant slipped and fell while scrubbing the floor causing injury to her right arm, right leg and low back. Total Incurred Value: \$97,146.20

2021215130 – Claimant was walking back to her office and slipped on water that was falling from the ceiling onto the floor causing her to fall and injure her right knee. Total Incurred Value: \$74,905.75

2021226936 – The claimant was out by the loading dock and tripped on uneven pavement and fell. Total Incurred Value: \$61,714.17
