2018128504 – Claimant tripped over the curb in the school parking lot after returning from lunch. Total Incurred Value: \$1,140,886.85

001198674 – Claimant was working on the athletic fields using a "pro-machine" to break frozen turf, when he hit a hole in the clay. Total Incurred Value: \$798,688.48

2019147541 – While lifting boxes and equipment, claimant strained left shoulder and left side of his neck. Total Incurred Value: \$352,931.94

2021232438 – Claimant slipped on a wet floor in the bathroom twisting his right knee. Total Incurred Value: \$194,042.07

2021228322 – While walking to bus and starting her shift, the claimant slipped and fell repeatedly on ice, injuring her back, right shoulder, head, bilateral knees and sustaining laceration to lip. Total Incurred Value: \$159,544.48

2020179337 – Stress and strain of employment duties either caused, aggravated, accelerated and/or exacerbated lumbar and cervical spine conditions. Total Incurred Value: \$156,856.00

2017094555 – After demonstrating drills with the basketball team, his right knee became sore, stiff and swollen. Total Incurred Value: \$104,330.38

2020194258 – While walking in classroom, the claimant tripped on a small carpet and heard a pop in her left heel. Total Incurred Value: \$92,778.82

2020181480 – While using the water hose to clean trash cans, claimant tripped over the hose and sprained her right ankle and twisted her right knee. Total Incurred Value: \$88,948.01

001217776 – Claimant sat down on a new chair, when the chair rolled backwards, causing her to fall onto her buttocks and injure her back. Total Incurred Value: \$73,704.84

2020193898 – Rising up from her chair at her computer, the claimant tripped on a wire causing her to fall and injure right knee, right hip, right foot, right wrist and hand. Total Incurred Value: \$57,495.49

2019151703 – While lifting a paint machine into the back of a truck, the claimant strained his lumbar spine. Total Incurred Value: \$48,853.00

2020179289 – Claimant was carrying boxes to her car, when she tripped and fell in the insured's parking lot, landing on her right side. Total Incurred Value: \$26,663.86

2021222329 - Claim alleging gender discrimination. Proposed Authority: \$60,000.00

2022243695 – Property damage claim for water incident from new roof and existing drain leaking into classroom. Total Incurred Value: \$22,500.00

2022243667 – Property damage from lightning strike to school damaging the school's router, POE projector and WAN link. Total Incurred Value: \$22,000.00
