CLOSED SESSION MINUTES

Thursday, May 18, 2017

A Closed Session of the Gloucester, Cumberland, Salem School Districts Joint Insurance Fund was held on May 18, 2017 at 1:20 pm, with Margaret Meehan, Washington Township, Chair, presiding.

CLAIM ADMINISTRATOR'S REPORT

Mr. Roselli introduced Claudia Acosta, who is the new Account Manager for the GCSSD JIF, replacing Kathy Tyler Schohl.

Ms. Acosta reviewed the following workers' compensation Payment Authorization Requests for May, 2017:

2017091067 01 – While upon a ladder, replacing the battery on an emergency light, the claimant misjudged a step, twisting his left knee and banging it on a railing. Total Incurred Value: \$59,783.00.

2017098658 01 – While trying to keep a special needs student from leaving the classroom, claimant pivoted, and felt/heard a pop in her left knee followed by pain/swelling. Total Incurred Value: \$60,130.00.

2017091604 01 – Claimant was getting down from a ladder after changing a light bulb when he missed a step and over-extended his right knee. Total Incurred Value: \$62,331.00.

2017094806 01 – While attempting to restrain a special needs student, the claimant rolled his right ankle. Total Incurred Value: \$86,076.00.

2017100953 01 – While walking to move ball/equipment from gym floor to prevent students from tripping over it, claimant pivoted, and felt a "pop" in his right knee. Total Incurred Value: \$86,315.00.

2016078587 01 – While pulling a box down from the top shelf in the storage closet, the claimant felt pain in her right shoulder. Total Incurred Value: \$126,278.00.

2016079676 01 – While at her desk, sitting on her chair, the claimant went to pick up a paper a student dropped and slipped out of her chair, falling onto her left arm. Total Incurred Value: \$141,201.00.

001223297 01 – The claimant was walking across the playground blacktop, when she slipped on ice and fell. Total Incurred Value: \$158,154.00.

2017086262 01 – Claimant was breaking up a fight between two female students, when she injured her right shoulder and neck. Total Incurred Value: \$88,900.00.

001195468 01 – Fell on a documented height difference on concrete walkway at school's entrance. Total Incurred Value: \$135,000.00.
