V. PROFESSIONAL REPORTS

A. Accountant/Treasurer

Ms. Verrill referred to the March and April, 2018 Bill Lists and Cash Reconciliation Reports for January, February, and March, 2018 found in the agenda. Ms. Verrill noted that all accounts are now receiving 1.65% interest from all banks.

- C. Executive Director/Underwriting Manager Summary

1. Executive Director

- a. 2018-2019 Membership Renewal: Mr. Wilkie reported that there are 26 districts within the local owner group funds that are up for membership renewal on July 1, 2018. They are as follows: ACCASBO 6 districts (all have renewed); BCIP 15 districts (14 have renewed, 1 has not: Mt. Holly will not be renewing); GCSSD 5 districts (all have renewed).
- b. *Potential Members Update:* Mr. Wilkie reviewed potential prospects and marketing strategy. Several districts across all Funds have expressed interest in membership. A marketing email has also been sent out, including the cyber technology white paper.
- c. SPELL JIF Website Enhancements: Ms. Fox reported that the new COI Module to submit requests for Certificates of Insurance through the SPELL website continues to progress. All districts are now using the new module. The Administrator's office continues to work through any issues internally. Member feedback is always welcome.
- Mr. Tennant and Ms. Matro presented a power point presentation regarding the new website program "Forum". Ms. Matro also reviewed data available with the Claims Summary Program. The SPELL Board of Trustees is in support of this program, which will compel Qual-Lynx to participate.

- d. *DUPRO Services:* Mr. Tennant reported that legal contract language review is not clear at this time with DUPRO, and the Executive Director's Office will not be moving ahead with this program.
- e. IT Advisory Committee Survey: Mr. Tennant reported that the IT Advisory Committee survey has been sent to all members, per action approved at the previous SPELL meeting. This questionnaire will allow the group to collect data on all SPELL JIF districts to see what issues related to Cyber Security need to be addressed so that a plan can be formulated to systematically provide support to address each issue to the benefit of all member districts. This data is being collected blind, except for a classification of district size to determine if there are similarities based on size.

- f. STOPIT User Group: Mr. Wilkie reported the Executive Director's Office is in the process of forming a SPELL JIF STOPIT users group. This group will meet once a year to purposely discuss the use and value of this application. Personnel from STOPIT will also be included in the group to assist them in perfecting the app on the SPELL's behalf. A M Best reached out to STOPIT, and interviewed GEHRHSD schools regarding the success of this program.
